Terms and Conditions

- All rates are quoted in Euro €, all bank transfer fees/charges are the responsibility of the delegate.
- No booking will be confirmed in full until full payment is received.
- Any refunds by bank transfer are subject to a €25 handling fee.
- Participants are requested to have their own travel insurance in place (to cover medical, cancellation and all other risks associated) and are responsible for all travel arrangements including visa applications if required.
- Keynote PCO acting as booking agent for the 50th World Irish Dancing Championships will not be held liable for any loss or damage of personal items of attendees or injury caused at any venue used in connection with the event.
- The Agent accepts no liability for any difficulties connected with travel of participants nor any responsibility for alteration or cancellation of the programme of this conference or event.
- The Agent does not accept responsibility for any inconvenience or costs due to non-availability of booked accommodation, tours or social events. Alternate arrangements will be made in event of unavailability, or monies received will be refunded to participants if suitable alternatives cannot be provided.

Cancellation Policy

- Cancellations and/or changes must be sent in writing to the registration desk at accommodation@worldirishdancing2020.com and will not be accepted by telephone
- There is no refund for non-attendance, no-show, late arrival or early departure
- Name changes on paid accommodation bookings are accepted up to two weeks prior to arrival date. After that date a charge of €10 per name change will apply.
- All leisure tours are subject to a minimum number of bookings. If the minimum number of bookings is not reached, the tour will unfortunately have to be cancelled. Two weeks' notice will be given of any such cancellations. In case of a cancellation, delegates will be offered a place on an alternative tour (should spaces be available) or a full refund.
